The Undersigned:

1. Has asked Inland Empire Airsoft and Paintball LLC to be allowed to play Airsoft or Paintball at any facility or field operated by Nitehawk Airsoft and Paintball, observe and acknowledges that the game involves physical exertion and other risks, known and unknown and my result to injury to the under signed or others playing the game, even if all safety rules are followed;
2. Is aware of the possibility or risks of injury, including, but not limited to, being shot by hunters, being caught in a rock, snow, or mud slide, insect bites & stings, poisonous snake or insect bites, cutting, stinging of piercing plants, improper use, malfunction or operation of equipment by the undersigned or any other player and others not following the safety rules. Player will be exposed to both natural and man made hazards. The possibility of permanent disability or even death does exist;
3. Agrees to play the game according the rules which have been explained, posted and provided and to follow directions given by any game Referees and/ or Administrators.
4. Warrants and acknowledges that his/ her physical condition is excellent and his / her mental state is sufficiently stable to enable him / her to participate safely in the game. This includes not being on any medication that would pose a risk to him / her under physically exerting conditions.
5. Agrees to use any Airsoft or Paintball equipment, special items, special weapons, restricted items in a manner which will not cause injury or damage to himself / herself or other playing;
6. Certifies that he / she is over 18 years old; or has parent or guardian sign below to play or observe.
7. Authorizes use of photos, videos, name, comments, game results, ect. for promotional purposes;
8. Understands and agrees to follow all safety rules and procedures and that such rules and procedures not followed by others could result in his / her injury or death;
9. Understands that serious and permanent eye injury including loss of eyesight can occur if approved Airsoft safety eye wear (ANSI Z87.1 2003 and/ or Paintball STD ASTM F17666-99 or EC equivalent) is not worn properly in any area where airsoft or paintball guns / weapons & specialty devices my be intentionally or accidentally discharged. I understand that it is my responsibility to wear approved safety eye wear and I accept that responsibility,
10. That individuals who are less than 18 years old must wear sealed eye wear and full face protection which conform to paragraph 9.
11. Understand that the safety eye wear can for or become dirty, an agrees that despite any, or other, such problems that he / she will keep them securely fastened to protect the eyes and will not remove them while on the playing field, at the chronograph, at the target range or in any other area where he / she might be struck by a Airsoft or Paintball projectile, other gas or spring powered projectile device used in Airsoft specialty device(grenade , land mine, rocket launcher, booby trap, ect.).
12. Understands that loss of hearing from an ear shot, disorientation and injury from throat, groin, head or ear shots can occur if proper safety equipment is not worn to protect these areas, and understands it is his / her responsibility to wear or not wear such items.

IN CONSIDERATION of being permitted to play the game, the undersigned, on behalf of himself / herself, his / her successors or assignees, hereby releases and forever discharges Inland Empire Airsoft and Paintball LLC, Nitehawk Airsoft & Paintball , their officers, agents & assignees; land owners, land lease holders or managers, equipment distributors, and their successors, assigns, employees, officers, agents and franchises, dealers or operators both jointly and severally, from any and all actions covenants, claims and demands of damages, cost, expenses(including attorneys' fees), loss or injury, however arising including negligence of Inland Empire Airsoft & Paintball, Nitehawk Airsoft & Paintball which may have been or may be sustained by the undersigned in any way related to or arising out of the playing Airsoft or Paintball(or observing) or the equipment or the natural environment. The undersigned desires and agrees to assume any and all risks. **THIS DOCUMENT IS INTENDED TO BE LEGALLY BINDING CONTRACT RELIEVING THE GAME OPERATORS AND EQUIPMENT SUPPLIERS AND THEIR EMPLOYEES FROM LIABILITY FOR INJURY TO YOU. IF YOU HAVE ANY DOUBTS CONCERNING ANY ASPECT OF ITS CONTENTS, CONSULT AN ATTORNEY BEFORE SIGNING IT.
